### **General Information:**

The Office of the Commissioner of Central Excise, Bengaluru-II having its Divisional offices viz, Office of the Deputy/Assistant Commissioner of Central Excise, Jalahalli Division / Peenya-I Division/Peenya-II Division/Dasanapura Division/ Dabaspeta Division located at No. 16/1, S.P. Complex , Lalbagh Road, Bengaluru -560027. The building measuring 29414 Sq.ft (excluding ground floor) is having office area of 25,197 Sq.ft. and common area of 4217 Sq.ft.

**(i). Jalahalli Division :-** Ist floor space measuring 5628 Sq.ft. office area and 777Sq.ft. common area consisting of Divisional Office along with its Range Offices.
