**TERMS AND CONDITIONS**

- 1) Sealed quotations separately for technical bid and financial bid are invited from the Service Providers for supply of vehicle of the description noted below on hiring basis, for used by the Central Excise Audit Commissionerate, Bangalore.
- 2) The following are the proposed requirements of vehicles to be supplied on hiring basis.

| Brand/Type of Vehicle | Requirement   | No. of Vehicles required     |
|-----------------------|---|------------------------------|
| Mid-Size Vehicle      | 1) 2500 Kms for 30/31 days for each month on minimum of 12 hours basis. | <b>1 vehicle</b>             |
| Small Size vehicles   | 2) 2000 Kms for 25 days for each month on minimum of 12 hours basis.    | <b>Maximum of 5 Vehicles</b> |

- 3) The last date for submission of both technical and financial bid is 26.09.2016 up to 14 hours. The bid shall be opened in the presence of bidder or their authorised agent at 1600 Hrs on 26.09.2016.
- 4) Such of the bids that are incomplete and /or received after the due date/time shall be liable for rejected summarily.
- 5) The rates/bid offer must be without any condition, assumption, qualification, reservation is variation etc. The rate/bid/offer shall be mentioned in both words and figures in case of any discrepancy of variation, the figures written words shall prevail for consideration.
- 6) The tender with lowest quoted rate and also meeting the technical specification shall be declared as successful bidder after due evaluation.
- 7) The rates/bid made and accepted by the department shall be firm and shall remain unchanged throughout the period of contract entered into with the bidder.
- 8) The initial term of contract will be from the date of entering into the vehicle agreement and for One year from the date of agreement and can be extended beyond on mutual agreement on the same terms and conditions.
- 9) The bidder shall have previous experience of providing such vehicle to any Government department/ public sector undertaking or to any reputed company. Proof for the same shall be submitted along with the tender.
