TERMS AND CONDITIONS

- 1) The tender for hiring of vehicles for use as Staff cars and operational vehicles in the Office of the Commissioner of C.Ex. Audit Commissionerate, Bengaluru is called for an agreement period of one year from the date of commencement of the agreement and that the Commissioner of Central Audit Commissionerate, Bengaluru reserves the right to extend the agreement for further period of twelve months after the expiry of initial period of agreement on the same terms and conditions.
- 2) Tenders sent by post if delivered by the post after the expiry of the specified time will only be recorded but not opened or considered. Such tender will be opened when a request is made by the tenderer to return any demand draft/bank guarantee enclosed as EMD/Bid Security. In such cases, the DD/Bank Guarantee will be returned in original. The other documents will be recorded and not returned.
- 3) Tenders received either by post or courier service or in person after the specified time will not be opened or considered.
- **4)** The tender will be accepted and agreement will be finalized only with those of the tenderer who in the opinion of the Commissioner of Central Excise Audit Commissionerate, Bengaluru, are having the capacity and resources to execute the assigned work.
