Preference will be accorded to those Service Providers who have sufficient experience in providing such services to various Government Departments, Public Sector Undertaking and Government Autonomous Organisations. The period of contract shall initially be for a period of one year extendable each time at the discretion of the Department, by a term of one year.

The tenders should be super scribed "Tender for Housekeeping Services" and be submitted in two sealed covers i.e. Technical bid and Financial bid, addressed to the Commissioner of Central Excise, Bengaluru-II Commissionerate, C.R. Building, Queens Road, Bengaluru-560001 with an EMD of Rs. 10,000/- (Rupees Ten Thousand only) in the form of a Demand Draft drawn in favour of PAO, Central Excise, Bengaluru. Tenders without EMD will be summarily rejected. The completed sealed tender documents should reach the office on or before **16.00 hrs on 26.03.2015**. Bids received beyond the specific date/time will not be accepted. **The Technical bids will be opened at 15:30 hrs on 27.03.2015 and the Financial bids will be opened at 16.30 hrs on 27.03.2015** in the presence of the designated committee. If any of the bidders likes to participate in tender opening process, they may be present at the venue at aforesaid time. The Office reserves the right to reject any prospective application without assigning any reasons. If any information furnished by the agency is found to be incorrect at a later stage, the agency shall be liable to be debarred from providing the services and may also face financial consequences.
