The Office of the Principal Commissioner of Central Excise, Bangalore I, invites tenders/quotations from the reputed service providers for providing of Security services at the Departmental Residential Quarters as mentioned in the **Annexure I**.

Preference will be accorded to those service providers who have sufficient experience in providing such services to various Government Departments, Public Sector Undertaking and Government Autonomous Organisations. The period of contract shall initially be for a period of one year extendable each time at the discretion of the Department, by a term of one year.

The tenders should be super scribed " Tender for Security Services " and shall be submitted in two sealed covers i.e. Technical and Financial , addressed to the Principal Commissioner of Central Excise, Bangalore I Commissionerate, C.R. Building, Queen's Road, Bangalore -560 001 with an EMD of Rs. 10,000/- (Rupees Ten Thousand only) in the form of a Demand Draft drawn in favour of PAO, Central Excise, Bangalore. Tenders without EMD will be summarily rejected. The completed sealed tender documents should reach the office by **15.00 hrs. on 23.05.2017**. Bids beyond the specified date and time will not be accepted. The Technical bids will be opened at **15.00 hrs on 24.05.2017** and the financial bids will be opened at **16.00 hrs on 24.05.2017** in the presence of the designated Committee. If any of the bidders like to participate in tender opening process, they may be present at the venue at aforesaid time. The Office reserves the right to reject any prospective application without assigning any reasons. If any information furnished by the agency is found to be incorrect at a later stage, the agency shall be liable to be debarred from providing the services and may also face financial consequences.
