

ORDER

Whereas, the Ministry of Home Affairs, Government of India vide Order No. 40-3/2020-DM-I(A), dated 14th April 2020 has issued directions to all the Ministries/Departments of Government of India, State/Union Territory Governments and State Union/Territory Authorities that the lockdown measures stipulated in Consolidated Guidelines dated 14th April 2020 of MHA for containment of COVID -19 epidemic in the country will continue to remain in force up to 03.05.2020.

Whereas, the Ministry of Home Affairs, Government of India with the intention of mitigating hardship of the public, has allowed select additional activities listed in the consolidated revised guidelines from the 20th April 2020 vide Order No. 40-3/2020-DM-I(A), dated 15th April 2020 and in this direction issued directions to all the Ministries/Departments of Government of India, State/Union Territory Governments and State Union Territory Authorities for strict implementation of the aforesaid consolidated revised guidelines.

Whereas, in exercise of the powers, conferred under the Disaster Management Act, 2005, the undersigned, in his capacity as Chairman, State Executive Committee, hereby issues directions to all Departments, District Deputy Commissioners, Superintendent of Police and other Heads of Departments that they shall continue to implement the measures presently in force in the State as stipulated in the Consolidated Guidelines of the Ministry of Home Affairs, Government of India vide Order No. 40-3/2020-DM-I(A), dated 14th April 2020 and State Government Orders to contain the spread of COVID-19 in the State till midnight of 21st April 2020.
