2. The sportspersons who are representing in the following Competitions/Tournaments shall be considered meritorious and are eligible for consideration:

- (i) A State / Country in the National / International competitions.
(ii) A University in the Inter-University tournaments conducted by the Inter-University Sports Board.
(iii) State Schools team in the National Sports / Games for schools conducted by the All India School Games Federation.
(iv) Those who have been awarded National Awards in Physical efficiency under the National Physical Efficiency Drive,

3. **Age Limit:** 18 to 27 years as on 01.03.2019. However relaxation of upper age limit upto a maximum of 5 years (10 years in case of SC/ST candidates and 8 years in case of OBC candidates.) is allowed for the purpose of appointment.

4. Educational Qualifications:

a) For the post of Tax Assistant

- (i) Minimum educational qualification of Graduation in any discipline from any recognized university.
(ii) Should possess a data entry speed of 8000 key depressions per hour.

b) For the post of Havaldar

- (i) Matriculation or equivalent from any recognized Board.
(ii) Candidates are required to possess the Physical Standards and pass the Physical Test as specified below

<p>(i) Physical Test: (a) Walking – 1600 metres in 15 minutes (b) Cycling - 8 kms. in 30 minutes.</p>	<p>(ii) Physical Standard (Minimum): Height – 157.5 Cms. Chest – 81 Cms. (Fully expanded with minimum expansion of 5 cms.) Height relaxable by 5 Cms. in the case of Garwalies, Assamese, Gorkhas and members of Scheduled Tribes.</p>

5. How to Apply:

Applications should be filled in the **Proforma given in Annexure** and should be sent to “**The Additional Commissioner (PCCO), Office of the Principal Chief Commissioner of Central Tax, P.B. No. 5400, C.R. Building, Queens Road, Bangalore – 560 001**”. The cover should be superscribed as “**Application for the post of Tax Assistant / Havaldar under Sports Quota Recruitment**”.

6. Certificates to be enclosed: Copies of the following certificates duly attested by a Gazetted Officer are to be enclosed along with the applications (No originals to be enclosed)

- (i) Sports Eligibility Certificate / Certificates for proof of Age, Education and other qualifications and for belonging to SC/ST/OBC.
- (ii) Certificate regarding representation in the Sports disciplines mentioned at para 1/ National Award in the prescribed form from the following authorities:


7. Preference will be given to those persons amongst the applicants who possess a certificate of representation in any of the events mentioned in para 2 above, held in 2016 and onwards

8. Selection process: On scrutiny of applications, the eligible candidates will have to appear in the field test in the respective sports discipline, written test (English, mathematics and general knowledge for a total of 100 marks), skill test (i.e. data entry speed test for Tax Assistant post) and Physical Test (for Havaladar post)

9. **Other conditions:**

- (a) Application for each post should be sent separately
- (b) Two Passport Size Photographs to be attached with the Application.
- (c) Application not containing the required details/ enclosures/ unsigned applications will not be considered.
- (d) The candidates are required to make their own arrangements for attending Field Test / Written Test / Interview, if called for by this office.
- (e) The selected candidates are liable to be posted anywhere in the State of Karnataka on appointment.
- (f) In case suitable candidates are not available in any of the games/sports, the department will not consider recruitment in that game/sports.
