Sub: Allocation of the candidates who have qualified based on the SSC CGLE 2024 to the post of Inspector in the Central Board of Indirect Tax and Customs – Reminder for Document Verification

The Central Board of Indirect Taxes and Customs (CBIC) has allotted 296 candidates for the post of Inspector to Bengaluru Zone based on the results of Combined Graduate Level Examination, 2024 conducted by the Staff Selection Commission.

2. As per G.S.R. 1172(E) dated 26.12.2016, the candidates are required to pass physical test and possess physical standard as described below, for appointment to the grade of Inspector (Central Tax / Preventive Officer / Examiner):

4. Candidates are advised to plan their itinerary for at least 2 days to attend PET/PST/Document Verification/Medical Examination. The process of Document Verification is subject to receipt and verification of dossiers by the designated authority in the Zone.

5. The Attestation Form, in original triplicate (3 originals), may be duly filled in all respects (filled by hand only) and produced at the time of document verification to the undersigned without fail. The last page of Attestation Form, called 'Identity Certificate' must be duly filled from a Gazetted officer of the Central or State Government or Stipendiary

Magistrates (3 originals with known period of at least 2 years).

6. Further, the candidates should bring the following documents (3 originals):

- i) Character certificate obtained from two different Gazetted Officers in the enclosed proforma (with a known period of at least 2 years).
- ii) One form of Personal Data duly filled by the candidate and signed.

7. Additionally, the candidates should bring the following documents (in original) along with 3 photocopies at the time of Document verification:

- i. Original SSLC/SSC/10th class Marks statement (for proof of date of birth)
- ii. Original Educational Qualification Degree(s)/Certificate(s) {Semester-wise marksheets in case of Degree(s), etc.}
- iii. Original Caste/Community Certificate, in case of SC/ST/OBC/EWS Certificate in the prescribed form (format enclosed) (must be valid as per SSC Notice for CGL Examination, 2024).
- iv. Discharge Certificate in case of Ex-Servicemen (must be valid as per SSC Notice for CGL Examination, 2024).
- v. Disability Certificate in case of Divyangjan (Persons with Disabilities) candidates (format enclosed) (must be valid as per SSC Notice for CGL Examination, 2024).
- vi. Four passport-size photographs.
- vii. Prescribed Photo ID cards like Aadhar/PAN/Voter ID/Driver License/ Passport, etc.
- viii. Income and Assets Certificate for Economically Weaker Section (EWS) Category candidates (must be valid as per SSC Notice for CGL Examination, 2024).
- ix. Discharge Certificate/NOC to attend DV from previous employer in case the candidate is employed in any of the offices under the Central Government/State Government, Autonomous Body, and Public Sector Undertaking presently. The certificate should be obtained with reference to this Notice.

8. As per DOP&T'S instructions, physically handicapped candidates must submit a Disability Certificate issued by the Competent Authority in the prescribed format (original & photocopy). The Competent Authority for issue of the Disability Certificate shall be a Medical Board duly constituted by the Central or State Government. Certificate not conforming to the prescribed format will not be accepted.

9. No Traveling Allowance/Daily Allowance will be paid in this regard.

10. This call letter is only for the purpose of consideration for appointment to the post of Inspector and shall not confer any right for appointment to the said post. Appointment orders shall be issued only after verification of the relevant documents specified above and will be issued thereafter. The candidates can return after completion of the formalities.
