- b) For the candidates of Mysuru Centre, Answer sheets of Paper II (Computer practical) shall be evaluated by the officer nominated and a letter intimating the marks awarded to the candidates shall be sent to NACIN Chennai along with the answer sheets and attendance sheets of Paper I (Central Excise, GST & Customs), Paper II (Computer Theory) and Paper III (Administration), The Print out/Hard Copy of answer sheet of Practical Examination need not be sent to NACIN Chennai.
- 5. Answer Sheets of Paper II (Computer theory) should not be evaluated by the Officers nominated to conduct the said examination.
