विषय/ Subject : Decentralization of Centralized Processing Centre for new GST Registration Applications – Reg.

The Centralized Processing Centre (CPC) of Bangalore Zone was established at 3rd floor, C.R.Building Annex, Queens Road, Bangalore 560001, in pursuance of Trade Notice No. 02/2017 dated 28.06.2017 issued by the Chief Commissioner, Central Tax, Bengaluru Zone.

- 2. It is now decided to decentralize the processing of new registration applications in Bengaluru Zone from the CPC to Divisional offices, effective from 14.05.2025. All new registration applications in the State of Karnataka whose application reference number (ARN) has been assigned to Central jurisdiction will be processed by the respective Divisional office from 14.05.2025. However, the existing ARNs already received in the CPC at the Zonal level, will continue to be processed by the CPC.
- 3. The Deputy/Assistant Commissioner of the respective Divisions will discharge the functions earlier discharged by the Deputy/Assistant Commissioner in charge of CPC, Bengaluru Zone. The Superintendents nominated by the CGST Commissionerates in each Division for the said purpose, will discharge the functions of the Proper Officer under Rule 9 and other relevant rules of CGST Rules, 2017 (as amended from time to time). The Trade Notice No. 1/2017 Central Tax dated 20.06.2027 issued by the Chief Commissioner, Central Tax, Bengaluru Zone (as amended from time to time), may be referred to for the purpose of jurisdiction.

- 4. The address and the contact details of the Divisional offices are enclosed in Annexure 'A'.
- 5. All Trade Associations are requested to bring the contents of this Trade Notice to the notice of members, manufacturers and trade in general.
- 6. This issues with the approval of the Competent Authority.
