विषय/Sub: Holding of Departmental Examination for Confirmation of Inspectors of
 Central Tax & Customs from 02.09.2025 to 04.09.2025 – Reg

The Departmental Examination for confirmation of Inspector of Central Tax & Customs is scheduled to be held in the month of September, 2025. The timetable and the syllabus for the aforesaid departmental examination are given in Annexure-I.

2. Applications in the prescribed proforma (ANNEXURE-II) are invited from the Inspectors desirous of taking the above examinations. Applications received from the willing candidates may please be sent to this office by 15.08.2025 as details of candidates have to be forwarded to NACIN Lucknow. The names of the willing officers may be sent immediately in one batch in the prescribed proforma indicating clearly the papers in which they desire to appear. It may be impressed upon that the applications received after the due date will not be considered.

4. According to the Departmental Examination Rules, 2024, Rule 6(1) "All officers who are required to pass the examination shall be permitted to avail as many chances as occur within the initial two-year period specified under rule 5 or any additional chance as may be granted in terms of sub-rule 6(2) to sub-rule 6(4) of this rule"

(2) The Principal Commissioner or Commissioner of Central Tax or the Principal Commissioner or Commissioner of Customs or the Narcotics Commissioner, as the case may be, (hereinafter referred to as the 'Commissioner') shall be competent to grant two additional consecutive chances immediately occurring, beyond the chances admissible during the normal period specified in rule 5, to the officers serving under him.

5. The details of the candidates have to be scrutinized by the respective Commissionerates. If any candidate is found not to have passed the confirmation exam within 2 years from the date of appointment, additional chance (1st / 2nd) is to be allowed at your end and same may be indicated in the proforma.

Request for 3rd additional chance, if any, is to be forwarded to this office for consideration by the Principal Chief Commissioner, Bangalore Zone.

6. Further, such candidates who have passed 'Hindi' as one the subjects in matriculation or equivalent or higher level may seek exemption from appearing in the said paper in terms of Rule 8(4) of the Departmental Examination Rules, 2024. As per this office letter C.No.II/12/06/2018 Estt 'B' PCCO C.T. (BZ) dated 12.02.2019, all such request received in your office may be examined at the respective Commissionerate. The exemption so granted may be communicated to this office for records.

7. Attention is invited towards the "Master Circular on Probation/Confirmation in Central Services" issued vide DoPT's O.M. No.28020/3/2018-Estt.(C) dated 11.03.2019 (Copy attached). It may be circulated among the concerned Officers and they may be advised to take the confirmation examinations seriously and pass the same within the stipulated time frame, failing which, action, deemed fit as per above DoPT's O.M. will be initiated.

8. The matter may be brought to the notice of all the Inspectors so that there are no grounds for any complaint that they were not informed of the same. Instructions to conduct the said examination are enclosed herewith. Applications received from **(TAs/EAs/ Stenographers (who joined before 26.12.2016))** desirous of taking Paper-IV (Law) may also be sent to this office.
