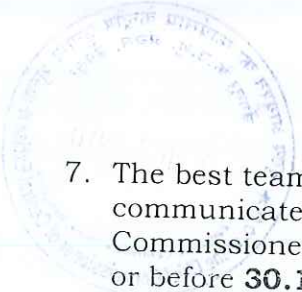

परिपत्र/CIRCULAR

In pursuance to the Central Vigilance Commission's direction, the "VIGILANCE AWARENESS WEEK" for the year 2018 will be observed from 29.10.2018 to 03.11.2018. In this connection it has been decided to conduct the following activities:

1. The pledge to eradicate corruption and to bring about integrity and transparency in all spheres of life will be administered to all Officers and staff at Headquarters office of each Commissionerates in Karnataka on **29th October 2018 at 11:00 Hrs.** The concerned head of office will administer the pledge at other offices on the said date and time. At the locations having various Commissionerates, the senior most officer may commonly administer the pledge at the said date and time.
2. All the staff and officers and the Trade may be encouraged to take the e-pledge by visiting CVC Website.
3. Banners and Posters to be displayed in Headquarters, Division Offices and field formations at important areas.
4. A Workshop on vigilance will be conducted at the Auditorium, Bengaluru East Commissionerate, Bengaluru. Details will be communicated in due course.
5. An essay competition on the theme "Eradicate Corruption- Build a New India" अष्टाचार मिटाओ - नया भारत बनाओ", not exceeding 300 words, will be conducted on 30th October, 2018 at the Auditorium, Bengaluru East Commissionerate at 11 a.m. The names of officers who wish to participate in the essay Competition may be intimated to the Superintendent, Vigilance Section, Bengaluru East Commissionerate, BMTC Building, Domlur, through the concerned Commissionerate's Vigilance Section on or before 29.10.2018. The topic for the Essay Competition will be communicated to the participants on the spot.

A debate competition based on the theme "**Eradicate Corruption- Build a New India**" will be conducted on **1st November, 2018** at the Auditorium, Bengaluru East Commissionerate from **11:00 hrs onwards**. Each Commissionerate shall nominate their Team (comprising two officers) for the debate Competition. The topic for the debate will be communicated at a later stage.

The best team from each Commissionerate for the Debate Competition should be communicated to the Superintendent, Vigilance Section, Bengaluru East Commissionerate through the concerned Commissionerate's Vigilance Section on or before **30.10.2018**. If no entry is received by the due date, it will be presumed that there are no nominations from that Commissionerate.
8. A function to conclude the Vigilance Awareness Week will be held on **2nd November 2018**. The venue and time for the function will be communicated in due course. All the Officers are requested to participate in the events organised as part of the "Vigilance Awareness Week 2018" and make it a grand success.
